BAC Resolution Recommending the Award of Project “CONSTRUCTION OF DRAINAGE CANAL AT PUROK 2, BANGANTALINGA, IBA, ZAMBALES” to GMR Construction and Supply

RESOLUTION NO. INFRA I2018-009

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for **CONSTRUCTION OF DRAINAGE CANAL AT PUROK 2, BANGANTALINGA, IBA, ZAMBALES** (INFRA 2018-009) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPS webpage continuously for seven (7) days dated June 26 – July 2, 2018;

WHEREAS, in response to the said advertisements, two intentions to bid were submitted, first is from GMR Construction and Supply and JORGZ KONZTRAK and Supply. The bid of JORGZ KONZTRAK and Supply was not accepted by the BAC due to late submission;

WHEREAS, the bid proposals of GMR Construction and Supply met the requirements and criteria during bid opening dated July 3, 2018;

WHEREAS, the bid proposals of GMR Construction and Supply passed the requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared GMR Construction and Supply as the single calculated bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds GMR Construction and Supply bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring GMR Construction and Supply to pass their post qualification evaluation;


WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- a) To recommend the AWARD of the Project “*CONSTRUCTION OF DRAINAGE CANAL AT PUROK 2, BANGANTALINGA, IBA, ZAMBALES*” to GMR Construction and Supply.
- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.




