BAC Resolution Recommending the Award of Project “CONSTRUCTION OF 162.72 LM DRAINAGE CANAL AT ZONE VI, IBA, ZAMBALES (INFRA 2017-021)” to GMR CONSTRUCTION AND SUPPLY

RESOLUTION NO. INFRA I2017-021

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for CONSTRUCTION OF 162.72 LM DRAINAGE CANAL AT ZONE VI, IBA, ZAMBALES in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPS webpage continuously for seven (7) days dated November 27, 2017 to December 4, 2017;

WHEREAS, in response to the said advertisements, only two intentions to bid was submitted, first is from JORGZ KONZTRAK AND SUPPLY from Lipay, Dingin, Iba, Zambales and second from GMR CONSTRUCTION AND SUPPLY from Dirita, Iba, Zambales. Both paid the bid documents fee.

WHEREAS, the both bid proposals met the requirements and criteria during bid opening dated December 18, 2017;

WHEREAS, the bid proposal of GMR Construction and Supply ranked as lowest calculated bid during the bid evaluation and upon recommendation of TWG, BAC declared the same as the Lowest Calculated Bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification” and having only a single calculated bid the same shall undergo post-qualification;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds the bid of GMR Construction and Supply to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring GMR Construction and Supply to pass their post qualification evaluation;


WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:
