**BAC Resolution Recommending the Award of Project “CONSTRUCTION OF 300 L.M. LINE CANAL AT KALYE GIPIT, BRGY. STA. BARBARA, IBA, ZAMBALES (INFRA 2017-015)” to GMR CONSTRUCTION AND SUPPLY**

**RESOLUTION NO. INFRA I2017-015**

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for CONSTRUCTION OF 300 L.M. LINE CANAL AT KALYE GIPIT, BRGY. STA. BARBARA, IBA, ZAMBALES in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPS webpage continuously for seven (7) days dated August 24, 2017 to August 30, 2017;

WHEREAS, in response to the said advertisement, only one intention to bid was submitted from GMR CONSTRUCTION AND SUPPLY from Dirita, Iba, Zambales. The bid document fee likewise paid.

WHEREAS, said bid proposal met the requirements and criteria during bid opening dated September 4, 2017;

WHEREAS, the bid proposal of GMR Construction and Supply is rated as single calculated bid during the bid evaluation and upon recommendation of TWG, BAC declared the same as the Single Calculated Bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification” and having only a single calculated bid the same shall undergo post-qualification;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds the bid of GMR Construction and Supply to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring GMR Construction and Supply to pass their post qualification evaluation;


WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.


