BAC Resolution Recommending the Award of Project "DESILTING OF TAKAR RIVER ALONG THE EASTERN PORTION OF ZONE VI, IBA, ZAMBALES (INFRA 2017-022)" to GMR Construction and Supply.

RESOLUTION NO. INFRA 12017-022

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid DESILTING OF TAKAR RIVER ALONG THE EASTERN PORTION OF ZONE VI, IBA, ZAMBALES in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPS webpage continuously for seven (7) days dated December 7 to 13, 2017;

WHEREAS, in response to the said advertisements, only one intentions to bid was received by the BAC, from GMR Construction and Supply from Dirita, Iba, Zambales, complete with proof of payment of bid documents fee.

WHEREAS, the bid proposal GMR Construction and Supply met the requirements and criteria during bid opening dated December 14, 2017;

WHEREAS, having only one bid proposal which pass requirements and criteria during the bid evaluation and upon recommendation of the TWG, BAC declared the same as the Single Calculated Bid:

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification" and having only a single calculated bid the same shall undergo post-qualification;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds GMR Construction and Supply bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring GMR Construction and Supply to pass their post qualification evaluation;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a) To recommend the AWARD of the Project "DESILTING OF TAKAR RIVER ALONG THE EASTERN PORTION OF ZONE VI, IBA, ZAMBALES under project reference No. INFRA 2017-022" to GMR Construction and Supply.
- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.
