## BAC Resolution Recommending the Award of Project "INSTALLATION OF RCPC AT SITIO MARANGLA, SAN AGUSTIN, IBA, ZAMBALES (INFRA 2017-017)" to Jorgz Konztrak and Supply

## **RESOLUTION NO. INFRA 12017-017**

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for "INSTALLATION OF RCPC AT SITIO MARANGLA, SAN AGUSTIN, IBA, ZAMBALES" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPS webpage continuously for seven (7) days dated October 19 to 25, 2017;

WHEREAS, in response to the said advertisements, three (3) bidders paid the bid documents fee but only Jorgz Konztrak and Supply of Iba Zambales submitted its letter of intent and applications for eligibility and to bid;

WHEREAS, the BAC and its TWG unanimously agreed that the two bidders who paid the bid documents fee but failed to submit their bids during the bid opening be given stern warning that should it repeat the same they will be barred from future bidding of LGU Iba, Zambales and that they will be recommeded for blacklisting in any government bidding activities.

WHEREAS, the bid proposal of Jorgz Konztrak and Supply met the requirements and criteria during bid opening dated October 26, 2017;

WHEREAS, having only one bid proposal which pass requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared the same as the Single Calculated Bid:

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid (or in this case the Single Calculated Bid) shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds Jorgz Konztrak and Supply bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring Jorgz Konztrak and Supply as eligible and responsive bid;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a) To recommend the AWARD of the Project INSTALLATION OF RCPC AT SITIO MARANGLA, SAN AGUSTIN, IBA, ZAMBALES under Project Reference No. (INFRA 2017-017) to Jorgz Konztrak and Supply of Iba, Zambales.
- b) To adopt all findings and other resolutions of the BAC and TWG pertinent to this project.
