**BAC Resolution Recommending the Award of Project “REHABILITATION AND IMPROVEMENT OF (730 LM) ACCESS ROAD AT SITIO AGNAYA BRGY. SAN AGUSTIN, IBA, ZAMBALES (INFRA 2017-016)” to JORGZ KONZTRAK AND SUPPLY**

**RESOLUTION NO. INFRA I2017-016**

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for “REHABILITATION AND IMPROVEMENT OF (730 LM) ACCESS ROAD AT SITIO AGNAYA BRGY. SAN AGUSTIN, IBA, ZAMBALES” in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPS webpage continuously for seven (7) days dated October 19-25, 2017;

WHEREAS, in response to the said advertisements, three (3) bidders paid the bid documents fee, they are Jorgz Konztrak and Supply of Iba, Zambales, GMR. Construction and Supply of Iba Zambales and Bancal Construction and Supply of Botolan Zambales. However, Bancal Construction and Supply and GMR. Construction and Supply of Iba Zambales failed to submit their bid on time hence it was rejected by the BAC Secretariat;

WHEREAS, the bid proposal of JORGZ KONZTRAK AND SUPPLY met the requirements and criteria during bid opening dated October 26, 2017 and is declared Single Bid during the bid opening;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds JORGZ KONZTRAK AND SUPPLY bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring JORGZ KONZTRAK AND SUPPLY to pass their post qualification evaluation;



- b) To adopt all findings and other resolutions of the BAC and TWG pertinent to this project.




