BAC Resolution Recommending the Award of Project "SUPPLY AND DELIVERY OF CONSTRUCTION AND HARDWARE MATERIALS FOR BRIGADA ESKWELA 2018 IBA DISTRICT, ZAMBALES (GOODS 2018-002)" to SUN RISE RJM CONSTRUCTION AND SUPPLY

RESOLUTION NO. NGP1-G2018-002

WHEREAS, the procurement for the project *SUPPLY AND DELIVERY OF CONSTRUCTION AND HARDWARE MATERIALS FOR BRIGADA ESKWELA 2018 IBA DISTRICT, ZAMBALES* under project reference no. *(GOODS 2018-00)* already undergone 3 failed bidding;

WHEREAS, the BAC decided to resort to negotiated procurement under two failed bidding enshrined under Section 53.1 of 2016 IRR of RA 9184 which states that;

Section 53. Negotiated Procurement *Negotiated Procurement is a method of procurement of Goods, Infrastructure Projects and Consulting services, whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant in any of the following cases:*

53.1. Two Failed Biddings. *Where there has been failure of competitive bidding or Limited Source Bidding for the second time as provided in Section 35 of the Act and this IRR. (a)*

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Request for Quotation for the "SUPPLY AND DELIVERY OF CONSTRUCTION AND HARDWARE MATERIALS FOR BRIGADA ESKWELA 2018 IBA DISTRICT, ZAMBALES" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for seven (7) days dated August 31 - September 7, 2018;

WHEREAS, in response to the said advertisement, three quotations were received by the BAC in sealed enveloped;

WHEREAS, the proposal of SUN RISE RJM CONSTRUCTION AND SUPPLY was declared the lowest calculated and responsive price quotation;






