BAC Resolution Recommending the Award of Project “CATERING SERVICES FOR TRICYCLE SUMMIT EVENT (GOODS 2018-020)” to RMB CATERING SERVICES

RESOLUTION NO. GOODS G2018-020

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for CATERING SERVICES FOR TRICYCLE SUMMIT EVENT (GOODS 2018-020) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPS webpage continuously for seven (7) days dated December 5-12, 2018;

WHEREAS, in response to the said advertisements only one bid was submitted. The sole bid submission was from RMB CATERING SERVICES of Zone VI, Iba, Zambales; complete with proof of payment of bid documents fee;

WHEREAS, the bid proposal of RMB CATERING SERVICES met the requirements and criteria during bid opening dated December 12, 2018;

WHEREAS, the bid proposal of RMB CATERING SERVICES passed the requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared the same as the Single Calculated Bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds RMB CATERING SERVICES bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring RMB CATERING SERVICES to pass their post qualification evaluation;

WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a) To recommend the AWARD of the Project “CATERING SERVICES FOR TRICYCLE SUMMIT EVENT (GOODS 2018-020)” to RMB CATERING SERVICES.
- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.


