**CONTRACT**

THIS CONTRACT made this 22nd day of May 2017 by and between;

The government of the Republic of the Philippines through the LOCAL GOVERNMENT UNIT OF IBA, Zambales, Philippines represented herein by the Municipal Mayor, HON. JUN RUNDSTEDT C. EBDANE (hereinafter called "the Entity") of the one part and Lyndelle Agro Industrial Sales owned by ALEJANDRO S. MALIBIRAN with registered office address at San Juan Extension, Dinalupihan, Bataan (hereinafter called "the Contractor") of the other part.

WHEREAS the Entity published/invited the Bids for purchase/acquisition of goods, viz., Supply and Delivery of Rice Combined Harvester under the LPRAT-BUB Project (herein after called "the Contract") as stated in the Invitation to Bid and has accepted a Bid by the Contractor of the supply and delivery of the said goods/product with the sum of One Million Nine Hundred Thousand Pesos and 00/100 (P/ 1,900,000.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.



3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract


