CONTRACT

THIS CONTRACT made this 16th day of April 2018 by and between;

The government of the Republic of the Philippines through the LOCAL GOVERNMENT UNIT OF IBA, Zambales, Philippines represented herein by the Municipal Mayor, HON. JUN RUNDSTEDT C. EBDANE (hereinafter called "the Entity") of the one part and WINSAR ENTERPRISE represented by Wincie S. Antonio, owner, with registered office address at 277A M. Roxas St., Brgy. San Roque, Marikina City (hereinafter called "the Contractor") of the other part.

WHEREAS the Entity is purchasing Celebrity Performers for Variety Show of Paynauen Festival on April 20, 2018 (herein after called "the Contract") in the amount of One Million Five Hundred Thousand Pesos and 00/100 (P/1,500,000.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
