C O N T R A C T

THIS CONTRACT made this 12th day of September 2018 by and between;

The government of the Republic of the Philippines through the LOCAL GOVERNMENT UNIT OF IBA, Zambales, Philippines represented herein by the Municipal Mayor, HON. JUN RUNDSTEDT C. EBDANE (hereinafter called "the Entity") of the one part and *SUN RISE RJM CONSTRUCTION AND SUPPLY* represented by its owner BEATRIZ D. DELA CRUZ with registered office address at Botolan, Zambales (hereinafter called "the Contractor") of the other part.

WHEREAS the Entity published/invited the Bids for purchase/acquisition of goods, viz SUPPLY AND DELIVERY OF CONSTRUCTION AND HARDWARE MATERIALS FOR BRIGADA ESKWELA 2018 IBA DISTRICT, ZAMBALES (herein after called "the Contract") as stated in the Invitation to Bid and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Six Hundred Forty Thousand Pesos and 00/100 (P640,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:


- (a) the Bid Form and the Price Schedule submitted by the Bidder;

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract


