**C O N T R A C T**

THIS CONTRACT made this 19<sup>th</sup> day of February 2018 by and between;

The government of the Republic of the Philippines through the LOCAL GOVERNMENT UNIT OF IBA, Zambales, Philippines represented herein by the Municipal Mayor, HON. JUN RUNDSTEDT C. EBDANE (hereinafter called "the Entity") of the one part and FRONTIER AUTOMOTIVE MARILAO CORPORATION represented by Renbert Tiu with registered office address at 333 Abangan Norte, MacArthur Hway, Marilao Bulacan (hereinafter called "the Contractor") of the other part.

WHEREAS the Entity published/invited the prospective supplier/contractors for purchase/acquisition of goods, viz., SUPPLY AND DELIVERY OF TWO MINI DUMP TRUCK FOR USE IN COLLECTING SOLID WASTE MATERIALS OF IBA, ZAMBALES (herein after called "the Contract") as stated in the Invitation and has accepted a price quotation by the Contractor of the supply and delivery of the said goods/product with the sum of **ONE MILLION NINE HUNDRED TWENTY THOUSAND PESOS and 00/100 (P/ 1,920,000.00)** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Price Quotation submitted by the Bidder;
  - (b) the Resolutions of the BAC;
  - (c) the Entity's Notification of Award and Notice to Proceed.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
