Invitation to Bid for CONSTRUCTION OF BOX CULVERT AT BRGY. DIRITA, IBA, ZAMBALES AND SATELLITE TREATMENT CENTER (PMDT) RHU IBA, ZAMBALES

- 1. The LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES, through the 20% DEVELOPMENT FUND, Approved under Ordinance No. 013 Series of 2014¹ intends to apply the sum of TWO HUNDRED FIFTY THOUSAND PESOS AND 00/100 (P/250,000.00) and TWO HUNDRED THOUSAND PESOS AND 00/100 (P 200,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for CONSTRUCTION OF BOX CULVERT AT BRGY. DIRITA, IBA, ZAMBALES, INFRA 15-13. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES now invites bids for CONSTRUCTION OF BOX CULVERT AT BRGY. DIRITA, IBA, ZAMBALES AND SATELLITE TREATMENT CENTER (PMDT) RHU IBA, ZAMBALES². Completion of the Works is required thirty (30) days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- Bidding will be conducted through open competitive bidding procedures using nondiscretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
