Invitation to Bid for ROAD SIGN AND SIGNAGES IMPROVEMENT ALONG MAJOR ROADS AT IBA, ZAMBALES

1. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES**, through the **20% DEVELOPMENT FUND, Approved under Ordinance No. 013 Series of 2014¹** intends to apply the sum of **THREE HUNDRED THOUSAND PESOS AND 00/100 (P/ 300,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **ROAD SIGNS AND SIGNAGES IMPROVEMENT ALONG MAJOR ROADS AT IBA, ZAMBALES, INFRA 15-14**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** now invites bids for **ROAD SIGNS AND SIGNAGES IMPROVEMENT ALONG MAJOR ROADS AT IBA, Zambales²**. Completion of the Works is required **twenty six (26) days**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **ENGINEERING OFFICE, MUNICIPAL HALL, R. MAGSAYSAY AVE., ZONE I, POBLACION, IBA, ZAMBALES** and inspect the Bidding Documents from **October 29 – November 5, 2015 (9:00 a.m. to 4:00 p.m.)**.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **FIVE HUNDRED PESOS (P/ 500.00)**.
6. Bids must be delivered to the address below on or before **November 6, 2015, 2:00 P.M.** at **ENGINEERING OFFICE, MUNICIPAL HALL, R. MAGSAYSAY AVE., ZONE I, POBLACION, IBA, ZAMBALES**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.


