AN ORDINANCE REGULATING THE OPERATION OF PERYAHAN AND CARNIVAL IN THE BARANGAY DURING FIESTA IN THE MUNICIPALITY OF IBA, ZAMBALES

Be it ordained by the Sangguniang Bayan of Iba, Zambales

**Section 1** – It shall be the policy of the Municipal Government of Iba, Zambales to regulate the operation of peryahan and carnival in the barangay only in connection with celebration of barangay fiesta, for a period of not more than 60 days.

**Section 2 – Definition of Terms:** When used in this Ordinance, the following terms shall mean:

- a. **Perya/peryahan** - a travelling enterprise offering a variety of games of chance which are legal in nature.
- b. **Carnival** - an enterprise which offers amusement or entertainment by means of one or more amusement ride.
- c. **Amusement ride** - shall mean any mechanized device or combination of devices, including electrical equipment which are integral part of the device or devices, which carries individuals/persons along, around or over a fixed or restricted course that aims to provide the persons amusement, pleasure, thrills or excitement.
- d. **Barangay Fiesta** - refers to a declared fiesta by the Sangguniang Barangay or in observance of the Feast of its Patron Saint.

**Section 3 – Rights, Privileges and Authority:** Subject to the provisions of applicable national law, rules and regulations, the Sangguniang Bayan of Iba, Zambales shall grant the rights,

privileges and authority to operate perya/peryahan or carnival before any permit is issued to applicant who shall meet the following qualifications.

- a. The applicant must be 21 years of age, Filipino Citizen. In case of juridical person, the applicant is duly organized and existing under Philippine Laws.
- b. The applicant must possess the required valid and subsisting certification to operate from the following institutions:
  1. The Barangay where the enterprise intends to operate.
  2. Educational Institution located within the proximity where the enterprise is proposed to be operated.

**Section 4 – Regulatory Mechanism:** Any privilege to operate a peryahan and carnival shall be conditioned on the grantee's faithful, continued and strict compliance with the following regulations:

**a. On Operator's Obligation:**

The operator shall register all his/her personnel to the Municipal Treasurers Office and pay the occupational permit fee of P/200.00 each. They shall be provided with I.D. valid for 60 days.

**b. On date and on time of operation:**

Operation of peryahan shall not start earlier than 5:00 o'clock in the afternoon and shall only be until 12 midnight. The time of operation can be extended up to 3:00 AM for seven (7) days prior to Feast Day.

**c. Period of operation:**

No perya/peryahan and carnival shall operate for more than 60 days at any given place in the Municipality of Iba, Zambales

**d. Coverage of Permit:**

Any permit to operate a peryahan or carnival is valid only for 60 days for every operation in the barangay.

**Section 5 – Special Provision:** Peryahan and carnival may be allowed to operate during Christmas Season and Foundation Day Celebration of Iba, Zambales only in Poblacion area for a period not exceeding 45 days.

**Section 6 – Penalty:** Anyone operating a peryahan and carnival without authority or permit shall be fined with P/2,500 or six (6) months imprisonment, or both upon the discretion of the court.

**Section 7 – Repealing Clause:** All other ordinances inconsistent with the provisions of this ordinance are hereby repealed and modified accordingly.

**Section 8 – Effectivity:** This Ordinance takes effect immediately.
