**AN ORDINANCE CREATING A TRICYCLE GRIEVANCE COMMITTEE TO HELP IMPLEMENT THE MUNICIPAL TRICYCLE FRANCHISING CODE AND TO INCLUDE A REPRESENTATIVE FROM THE OFFICE OF THE MAYOR IN THE MUNICIPAL TRICYCLE FRANCHISING REGULATORY BOARD (MTFRB)**

**Be it Ordained by the Sangguniang Bayan of Iba, Zambales.**

**SECTION 1 – PURPOSE** – To properly implement the provisions of the municipal tricycle franchising code, a grievance committee composed of tricycle stakeholders is hereby created. For the same reason, it is also important that a representative of the Office of the Mayor be added to the members of the MTFRB.

**SECTION 2 – JURISDICTION OF THE GRIEVANCE COMMITTEE:**

1. The grievance committee (committee) shall have original and exclusive jurisdiction to investigate and recommend to the Municipal Tricycle Franchising and Regulatory Board (MTFRB or Board) for disposition or resolution of all complaints regarding the grounds for suspension and/or revocation of tricycle franchise and whether or not the franchise shall be suspended or revoked.
2. The committee shall also have the original and exclusive authority to hear and recommend to the board questions arising out of the imposition of fines and other fees for violation of the tricycle code (code).

3. The committee may also be a forum to settle differences in the enforcement of the code.
4. Finally, the committee shall also have the same authority to recommend to the board if there are controversies relative to the implementation of the municipal tricycle and regulatory code.

The enforcement of the provisions of the code shall be the sole authority of the executive through its traffic and law enforcement officer. The executive, in the enforcement of the code may, in its discretion, also create a task force to help him/her to focus providing the right solution to the perennial problems of tricycle for hire and the violators of the code.

### **SECTION 3 – COMPOSITION OF THE COMMITTEE**

The committee shall be composed of the following persons:

1. The chairman of the SB Committee on Transportation
2. The SB Secretary
3. One representative from the Office of the Mayor
4. The head of the Traffic Enforcement Group
5. Two representatives from the Tricycle Operators and Drivers' Association (TODA) of Iba
6. One representative from the PNP of Iba

During its regular meeting, the members shall elect among themselves the Chairman and Vice Chairman of the Committee.

### **SECTION 4 – DESIGNATION OF ONE REPRESENTATIVE FROM THE OTHER OFFICE OF THE MAYOR**

The Municipal Mayor shall designate its representative to the MTFRB as regular member of the said board. The said representative shall exercise the same power and prerogative as exercise by the other members.

### **SECTION 5 – MEETINGS OF THE GRIEVANCE COMMITTEE**

The committee shall meet at least once a month preferably Wednesday at 2:00 PM to receive complaints or to act on all and appropriate matters brought before it.

SECTION 6 – EFFECTIVITY – This Ordinance takes effect upon approval.
