AN ORDINANCE TO AMEND SECTION 3 OF ORDINANCE NO. 004, SERIES OF 2014, ENTITLED AN ORDINANCE ESTABLISHING THE SITE OF THE NEW IBA PUBLIC MARKET AT BARANGAY DIRITA, IBA, ZAMBALES ON THE LOT PROPERTY OWNED BY MR. ENRIQUE LOZANO AND RYZZA JERESANO CONTAINING AN AREA OF TWO (2) HECTARES AND RECLASSIFYING THE SAME AS INSTITUTIONAL LAND

Be it ordained by the Sangguniang Bayan of Iba, Zambales

WHEREAS, two sections in Ordinance No. 004, Series of 2014 were numbered the same as Section 3;

WHEREAS, the subject of this ordinance is on the second section 3, which read as follows: "These lot properties are deemed reclassified from agricultural to institutional including the properties owned by Mr. Guillermo Gamboa that will be used as access road towards the proposed public market site, and to re-number the two sections numbered as three (3);

WHEREFORE, on motion of Kgd. Alcade R. Fallorin, unanimously seconded, the Sangguniang Bayan in session assembled;

Resolved to enact this ordinance;

SECTION 1 – The two (2) sections numbered the same as number three (3) shall be renumbered as follows,

- a. The first paragraph of Section 3 shall be numbered as Section 3A, while the second paragraph shall be Section 3B;

SECTION 2 – Section 3B shall be amended to: These Lot properties including the lot property owned by Mr. Guillermo Gamboa are now deemed reclassified from agricultural to commercial land because the public market offers commercial activity.

SECTION 3 – All other provisions of Ordinance No. 004, Series of 2014 shall remain the same.

SECTION 4 – This Ordinance takes effect upon approval.
