**AN ORDINANCE APPROVING THE NAMING OF STREETS IN BARANGAY SAN AGUSTIN, IBA, ZAMBALES**

Be it ordained by the Sangguniang Bayan of Iba, Zambales.

Whereas, the Sangguniang Barangay of San Agustin has enacted an ordinance naming the streets in the various Sitio's and Purok's in the Barangay;

Whereas, there are 19 existing streets in seven (7) Purok's and the Sitio's of Barangay San Agustin, Iba, Zambales with corresponding proposed street names;

Whereas, the power to name a public road/street is vested with the Sangguniang Bayan as provided for in the 1991 Local Government Code;

Wherefore, on motion of Kgd. Alcade Fallorin, Kgd. Genaro Montefalcon and Kgd. Francisco Aldea, unanimously seconded, the Sangguniang Bayan of Iba, Zambales in session assembled;

Resolved to enact this Ordinance.

Section 1 – The naming of streets in Barangay San Agustin, Iba, Zambales are hereby approved as follows:

Section 3 – It shall be the duty of the Barangay Government of San Agustin to install the street names after the approval of this ordinance.

Section 4 – This ordinance takes effect upon approval.
