**BAC Resolution Declaring WINSAR ENTERPRISE as the Single Calculated and Responsive Quotation and its Award for the project Purchase of Celebrity Performers for Variety Show of Paynauen Festival and Recommending for the Approval of the Head of Procuring Entity**

**RESOLUTION NO. 2018-ART-01**

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA thru its Tourism Officer, Ms. Alyssa M. Castro, procuring Celebrity Performers for Variety Show of Paynauen Festival on April 20, 2018.

WHEREAS, the BAC thoroughly considered and evaluated the proposal of the Tourism Officer and has agreed that the best mode of procurement as provided in 2016 IRR of RA 9184 is the Alternative Method of Procurement – Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services (Section 53.6). The BAC also agreed that bidding is still the primary mode of procurement hence they instructed the tourism officer to justify the use of Alternative Method against the bidding modality,

WHEREAS, the Tourism Officer justified the use of Alternative Method of Procurement stating that it cannot invite talent scouts/managers because celebrity/artists have specific handlers and managers.

WHEREAS, the Approved Budget for the above Contract of is One Million Five Hundred Thousand Pesos and 00/100 (P/ 1,500,000.00);

WHEREAS, the Terms of Reference and Request for Quotation were sent to at least three prospective talent scouts/suppliers of known qualification to determine if they can provide the requested artist who will perform in the variety show of Paynauen Festival. The three talent scouts/suppliers were;

WHEREAS, Section 53.6 of the 2016 IRR of RA 9184 (Government Procurement Reform Act) allows the procuring entity to resort to Alternative Mode of Procurement for Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services provided that the end-user complied with the required procedural requirements of GPPB.

WHEREAS, the evaluation of all submitted documents shows that WINSAR ENTERPRISE is the only talent scout/supplier which can provide the requested celebrity performers.

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) That WINSAR ENTERPRISE is Single Calculated and Responsive Quotation and is recommended for award of the said project;


- b) To recommend the approval of this resolution to the Municipal Mayor of Local Government Unit of Iba, Zambales the foregoing findings.






