BAC Resolution Recommending the Award of Project "CLEARING AND CORRECTION OF ROADWAY SHOULDER OF 3,200 LM SITIO ALWAB ROAD" to JORGZ KONZTRAK & SUPPLY

RESOLUTION NO. INFRA I2019-007

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for **CLEARING AND CORRECTION OF ROADWAY SHOULDER OF 3,200 LM SITIO ALWAB ROAD** (INFRA 2019-007) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for eight (8) days dated February 11-19, 2019;

WHEREAS, in response to the said advertisements, two intentions to bid were submitted, first is from JORGZ KONZTRAK & SUPPLY; and the other is from GMR Construction and Supply; both paid the bid documents fee;

WHEREAS, the bid proposal of met the requirements and criteria during bid opening dated February 19, 2019;

WHEREAS, the bid proposal of GMR Construction and Supply was declared highest calculated bid while JORGZ KONZTRAK AND SUPPLY was declared the Lowest Calculated Bid upon recommendation of TWG;

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds JORGZ KONZTRAK AND SUPPLY bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring JORGZ KONZTRAK AND SUPPLY to pass their post qualification evaluation;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a) To recommend the AWARD of the Project "**CLEARING AND CORRECTION OF ROADWAY SHOULDER OF 3,200 LM SITIO ALWAB ROAD**" to JORGZ KONZTRAK AND SUPPLY.
