BAC Resolution Recommending the Award of Project "REHABILITATION OF SITIO ANOLING-BATAAN IRRIGATION SYSTEM" to JORGZ KONZTRAK & SUPPLY

RESOLUTION NO. INFRA I2018-023

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for **REHABILITATION OF SITIO ANOLING-BATAAN IRRIGATION SYSTEM** (INFRA 2018-023) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for more than seven (7) days dated December 21-28, 2018;

WHEREAS, in response to the said advertisements, only one intention to bid was submitted, from **JORGZ KONZTRAK & SUPPLY**, complete with proof of payment of bid documents fee;

WHEREAS, the bid proposals of **JORGZ KONZTRAK & SUPPLY** met the requirements and criteria during bid opening dated December 28, 2018;

WHEREAS, the bid proposals of **JORGZ KONZTRAK & SUPPLY** passed the requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared **JORGZ KONZTRAK & SUPPLY** as the single calculated bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds **JORGZ KONZTRAK & SUPPLY**'s bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring **JORGZ KONZTRAK & SUPPLY** to pass their post qualification evaluation;


WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


