C O N T R A C T

THIS CONTRACT made this 8th day of January 2019 by and between;


The government of the Republic of the Philippines through the LOCAL GOVERNMENT UNIT OF IBA, Zambales, Philippines represented herein by the Municipal Mayor, HON. JUN RUNDSTEDT C. EBDANE (hereinafter called "the Entity") of the one part and ANB ENTERPRISES represented by its owner **BERNADET P. VILLANUEVA**, with registered office address at Zone VI, Iba, Zambales- (hereinafter called "the Contractor") of the other part.

WHEREAS the Entity published/invited the Bids for purchase/acquisition of goods, viz SUPPLY AND DELIVERY OF VARIOUS INFORMATION TECHNOLOGY EQUIPMENTS FOR DIFFERENT DEPARTMENTS OF LGU-IBA, ZAMBALES (herein after called "the Contract") as stated in the Invitation to Bid and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Hundred Ninety-Four Thousand Nine Hundred Pesos and 00/100 (P 394,900.00)** (hereinafter called "the Contract Price").

 - (g) the Entity's Notice of Award.



The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.




