### CONTRACT

THIS AGREEMENT, made this 6<sup>th</sup> day of February, 2019 between the LOCAL GOVERNMENT UNIT OF IBA, Zambales, Philippines represented herein by the Municipal Mayor, HON. JUN RUNDSTEDT C. EBDANE (hereinafter called "the Entity") of the one part and JORGZ KONZTRAK & SUPPLY of Iba, Zambales owned by JORGE N. ABAD JR. (hereinafter called "the Contractor") of the other part:

WHEREAS, the Entity is desirous that the Contractor execute "**A. CONCRETING OF 437 LM DOLIT ST. – TWINS ROAD AT DOLIT ST. (POSADAS), BRGY. PALANGINAN, IBA, ZAMBALES; B. CONCRETING OF 182 LM POSADAS-DOLIT ST. ROAD (PHASE 2) AT DOLIT ST. (POSADAS), BRGY. PALANGINAN, IBA, ZAMBALES**" (hereinafter called "the Works") and the Entity has accepted the Bid for **Lot A. Three Million Sixty-Seven Thousand Five Hundred Fifty-Two Pesos and 96/100 (P3,067,552.96); for Lot B. One Million Nine Hundred Sixty-Six Thousand Nine Hundred Twenty-Eight Pesos and 18/100 (P1,966,928.18);** respectively by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) General and Special Conditions of Contract;
  - (b) Drawings/Plans;
  - (c) Specifications;
  - (d) Invitation to Apply for Eligibility and to Bid;
  - (e) Instructions to Bidders;
  - (f) Bid Data Sheet;
  - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Credit line issued by a licensed bank, if any;
  - (l) Notice of Award of Contract and the Bidder's conforme thereto;
  - (m) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute

and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
