C O N T R A C T

THIS CONTRACT made this 27th day of August 2019 by and between;

The government of the Republic of the Philippines through the LOCAL GOVERNMENT UNIT OF IBA, Zambales, Philippines represented herein by the Municipal Mayor, **HON. JUN RUNDSTEDT C. EBDANE** (hereinafter called "the Entity") of the one part and **KAE CONSTRUCTION AND SUPPLY** represented by its owner **KENNITH ANTHONY T. EBUENGAN** with registered office address at Yman St. Brgy. Poblacion, Candelaria, Zambales (hereinafter called "the Contractor") of the other part.

WHEREAS the Entity published/invited the Bids for purchase/acquisition of goods, viz., **SUPPLY AND DELIVERY OF CONSTRUCTION AND HARDWARE MATERIALS FOR DIFFERENT SCHOOLS OF IBA, ZAMBALES** (herein after called "the Contract") as stated in the Invitation to Bid and has accepted a Bid by the Contractor of the supply and delivery of the said goods/product with the sum of **One Million Thirty-Seven Thousand Two Hundred Ninety-Eight and 99/100 pesos (P/1,037,298.99)** (hereinafter called "the Contract Price").




